



4. The business operations of the company and its subsidiaries were impacted due to temporary shutdown of the plant following nationwide lockdown announced by the Government in view of COVID-19 pandemic. The company and its subsidiaries have made detailed assessment of its liquidity position for the next year and the recoverability and carrying value of its assets including property, plant and equipment. Based on current indicators of future economic conditions, it is expected to recover the carrying value of these assets and management of the company does not foresee any risks in the Group ability to continue as going concern and meeting its liabilities. It will continue to closely monitor any major changes arising due to future economic conditions and its impact on the business.
5. Exceptional Item of Rs. 487.32 Lakhs (net) income in the consolidated figures for the year ended 31.03.2020 includes forgoing of long term liability/ WCPL of the subsidiary companies under the OTS Scheme of the bank.
6. The figures for the quarter ended 31st March'2020 and 31st March' 2019 are arrived at as difference between audited figures in respect of full financial year and the unaudited reviewed figures upto nine months of the relevant financial year.
7. Figures for the previous period/ year have been regrouped and reclassified to confirm to the classification of current period, wherever necessary.
